

Pepco Maryland SOS Bid Results from April 19, 2010 Solicitation

Pepco Residential and Small Commercial

This solicitation included the Residential and Small Commercial 24-Month term starting October 1, 2010 through September 30, 2012.

A total of nine (9) bid blocks were offered representing 29.7% of the load and totaling approximately 457.2 MW PLC at time of Bid. All requirements were filled.

There were 15 eligible bidders in the 2010 – 2011 RFP Procurement Process of which 12 suppliers submitted bids and 2 suppliers won a portion of the load offered.

Pepco Type II Non Residential

This solicitation also included the first quarter 2010, three month term for June, July, and August 2010.

A total of six (6) bid blocks were offered representing 100% of the load and totaling approximately 298.2 MW PLC at time of Bid. All requirements were filled.

There were 15 eligible bidders in the 2010 – 2011 RFP Procurement Process of which 7 suppliers submitted bids and 3 suppliers won a portion of the load offered.
